

- It is further informed that payment of semester fees will be accepted only through **State Bank Collect (Guidelines attached) 10th July, 2019 to 17th July, 2019**. The receipt of payment of the fee need to be produced by the students on the date of registration. **If any student fails to deposit the fee within the stipulated date & time, fine @ Rs. 500/- per day will be charged extra.** Please note that no student shall be allowed for registration in Odd Semester after **26th July, 2019** (i.e. last date of registration with late fee). Further, approval of Competent Authority for late registration beyond the last date of registration as special case will invite fine @ Rs.200/- per day.
- The Actual Date of registration for Odd Semester is also mentioned in the Academic Calendar for the session 2019-2020 available on Institute Website for information of all students/Faculty or other concerned staff members.
- The Students who intend to deposit the fee through Demand Draft on account of their education loan are advised to request their Banker(s) to deposit the same through SBI Collect to NIT Hamirpur (H.P.) or Demand Draft issued by any scheduled Bank in favour of Registrar, NIT Hamirpur payable at Hamirpur (H.P). Fee through Demand Draft has to be submitted one day before the actual date of registration.
- The students who are getting tuition fee waiver on the basis of parental income certificate are advised to produce fresh income certificate issued by the Competent Authority of Revenue Department concerned at the time of final registration, failing which they will have to pay the full tuition fee.
