DECISION:

The Board members were appraised about the details of the advertisement, screening criteria, screening process and declaration of list of 'Eligible and Shortlisted', 'Eligible-but-not-Shortlisted' and 'Ineligible' candidates, process considered for dealing with the representations of 'Ineligible' and 'Eligible-but-not shortlisted' candidates and selection process etc. The Board was also informed about the constitution of Selection Committee for various departments provided in clause 23(5)(a) of NIT statutes. Considering the above details, all the nine (09) sealed envelopes containing recommendations of the Selection Committee made in the meetings held during 23/08/2019 to 09/09/2019 for faculty recruitment at the level of Assistant Professor (Grade-II) were opened.
