BOG-1st SPL. MEETING/20 22-06/02:

Approval for authorization of Director for inviting expert from the approved panel list of expert for selection process of faculty in NIT Hamirpur in terms of Clause -2 and Clause-3 of Appendix-A1 circulated by MoE (erstwhile MHRD) vide its letter No.F.No.33-9/2011-TS-III dated 30th November, 2017.

It is submitted that Ministry of Human Resource Development (Now MoE) New Delhi has communicated the clarification on Recruitment Rules for faculty in NITs and IIEST vide its letter F.No.33-9/2011-TS-III dated 30th November, 2017 enclosing therein the guidelines/procedure related to recruitment process of the faculty positions. The clause-2 & clause-3 of the Appendix-A1 of the referred letter are reproduced as under:

CLAUSE-2

The Institute will create a panel of experts and upgrade it on annual basis. The list will be prepared by taking inputs from Departments. Director may also add extra names or delete some from the list. Normally, the experts should be drawn from NITs, IITs, IIMs, IISERs, IISc, IIEST, University Departments, major R&D Laboratories (CSIR, ICAR, DAE, ISRO, DRDO etc.) and major industry. The list, along with postal and electronic addresses, designations, specialization and other relevant particulars of proposed experts is to be placed before the Senate and then the BoG for their approval. Every higher authority shall have the power to add and delete names. In addition, fellows of INAE and the 3 Science academics will be automatically included in the panel. Every attempt should be made to ensure that major specializations of each department are adequately represented in the panel.


CLAUSE-3

While the above is a permanent list, update periodically, preferably every year, the BOG, at its discretion, may permit Director to choose experts for every single selection process from the full panel or from specific sub panels.






