Engagement of Advocate(s) as Institute Counsel at Hon'ble High Couπ of Himachal Pradesh to defend the cases where the Union of India is not a party

Engagement of Advocate(s) as Institute Counsel to defend the stand of NIT Hamirpur (H.P) in District Court, Hamirpur (H.P) on case to case basis through Expression of Interest (EOI)

Background: It is submitted before the Board that in reference to Office Memorandum No.F-No.J-12012/2/2017-Judical dated 29th June, 2017 issued by Department of legal affairs, Ministry of Law and Justice which emphasises that in the cases where Union of India is a party along with autonomous body, both should be defended by the Department of Legal Affairs' Panel Counsel. As a result, NIT Hamirpur has engaged Sh. Balram Sharma, Assistant Solicitor General of India (ASGI) as Institute Counsel at Hon'ble High Court, Himachal Pradesh, Shimla to defend the stand/position of National Institute of Technology, Hamirpur alongwith

Union of India on counsel fee as notified by the Department of Law and Justice from time to time, as per order No.J-11014/2/2020-Judical dated 28th January, 2021. Now, all such cases in which the Union of India is also a party along with NIT Hamirpur (H.P), the same are being defended by the Assistant Solicitor General of India (ASGI) as Institute Counsel at Hon'ble High Court, Himachal Pradesh, Shimla. Earlier, an agenda item was placed in 46th BOG vide item no. BOG/46/2021-10/07

- (i) for the Engagement as Institute Counsel at Hon'ble High Court of Himachal Pradesh to defend the cases where the Union of India is not a party
- (ii) for the engagement of Advocate to defend the stand of NIT Hamirpur (H.P) on retainership basis through Expression of Interest (EOI)

The same was duly approved by the Board and accordingly notification was issued vide No. NIT/HMR/BoG-46th /2021/12025-28 dated 08-12-2021.

Now, for smooth execution of litigation on behalf of Institute and to defend the stand of the Institute at Hon'ble High Court, Himachal Pradesh (H.P) wherein the UOI is not a party, Institute intends to engage two more Advocates as Institute Counsel at Hon'ble High Court, Himachal Pradesh on case to case basis for defending and taking legal opinion etc.

Similarly, for smooth execution of litigation on behalf of the Institute and to defend the stand of the Institute at District Court, Hamirpur (HP), Institute intends to engage two more Advocates as Institute Counsel at District Court, Hamirpur on case to case basis for defending and taking legal opinion etc.

The matter is placed before the Board for consideration and approval, please.

#### Decision:

The Board approved the proposal and suggested the following:

- (i) For smooth execution of litigation on behalf of the Institute and to defend the stand of the Institute at Hon'ble High Court, Himachal Pradesh on case to case basis and to take legal opinion etc., the panel of at least 2-3 reputed Advocates may be prepared by taking consent of Advocate(s)
- (ii) For smooth execution of litigation on behalf of the Institute and to defend the stand of the Institute at Distt. Court, Himachal Pradesh on case to case basis and to take legal opinion etc., and a panel of at least 2-3 Advocates be prepared after inviting EOI.

Further, the Board authorized the Director, NIT Hamirpur to take services from any of the Advocate(s) from the panel so prepared for Hon'ble High Court, Himachal Pradesh and District Court, Hamirpur and for payment of their Counsel fee as per actual bills raised.

Meeting ended with vote of thanks to the Chair.
