Accordingly, the work amounting to ₹ 7.25 lakh has been prepared on HPSR by Construction Cell and approved by the Technical Committee in its meeting held on 2nd July, 2015 and is placed for consideration.

C/o Boys Hostel No. VIII (Mega Hostel) (A/A & E/S = ₹ 120.57 Crore) The FC and BOG has accorded its approval for the Construction of 3^{rd} Block of the Mega Hostel in its meetings held on 27^{th} July, 2014 with the condition that in no case the cost of this work should exceed estimated amount of \gtrsim 120.57 Crore already approved for the purpose.

Keeping in view the facts that two blocks of Mega Hostel along with other peripheral infrastructure were constructed by M/s RITES Ltd at an approximate cost of ₹ 77.00 Crore and their less initiatives to rectify the shortcomings and defects in the work executed earlier and also failure to submit the Utilization Certificate (final bill) of the expenditure incurred so far, the matter was placed before the FC/BOG meetings held on 18.03.2015.

After detailed deliberation, the FC/Board resolved vide Resolution No. FC/MIN/18/ 2014-12/05 and BOG/MIN/27/2015-03/08 that prior to terminating the contract, final notice may be given to M/s RITES India Ltd as per clause of the contract/MoU signed between both the parties. Accordingly, final notice has been issued to M/s RITES India Ltd. vide No. NIT/HMR/CC/CB/15/Rites/285-90 dt 18.05.2015. Despite this, M/s RITES India Limited has not yet submitted the final bill (UC) of the work done so far.

It is therefore proposed that the remaining construction work of 3rd Block of Mega Hostel be got executed through the Construction Wing of the Institute, so that its completion is ensured within the approved estimated cost of ₹ 120.57 Crore as per the earlier decision of the FC/BOG dated 27.07.2014 vide Resolution No. BOG/25/2014-07/11. The drawing of the Block III and estimate amounting to ₹ 27.16 Crore as submitted by the Architectural Consultant is placed before BWC for approval.
