ii) In view of large number of representations from the students on the weightage of marks for Mid Semester, Semester Assessment and Term Project, the decision was revised with due consent of Senate Members vide notification No .NIT/HMR/Academic/32ndSENATE/2020/ 27235 dated 17/07/2020

Decision:

The SENATE ratified the approval accorded by the Hon'ble Chairman, SENATE on points i) 1 to 16 and ii) with the following suggestions and modifications as detailed below:

a) Sr.No.4-- Regarding online theory classes:

Feedback from the students regarding online classes shall be taken by the faculty concerned by 15th September, 2020 and conveyed to HOD of the respective Department. The HoDs shall intimate the same to the Academic Section.

b) Sr. No. 14--Open elective subjects:

The SENATE agreed in principle that the Architecture Department shall offer AutoCAD as an open elective. The course content shall be framed by the department concerned and submitted through DDPC and SBPC for further approval.

c) Sr.No. 16—Two Senate Nominees to BOG regarding:

At the outset the guidelines framed in the 18th SCOS meeting were approved by the entire Senate including the External Senate Members in ONE Voice and were applauded by the Senators, with a few suggestions to make these more acceptable to all concerned. It was termed as the most positive and democratic decision in the history of 34 years of REC/NIT Hamirpur HP.

The suggestions of the Senate were as mentioned below:-

(i) For nominating two faculty-members by the Senate as BOG members, two panels shall be formed. One panel from amongst the Professors and the other panel from amongst the Associate Professors or the Assistant Professors serving the Institute.



- (ii) Three names of the Senior-most Professors, who have not served as member of BOG, in any capacity, are to be proposed in the first panel. Any one name from amongst the panel of the three names of the Professors shall be nominated by the Senate as BOG member.
- (iii) In the second panel, three names of the Senior-most Associate Professors or Assistant Professors (as the case may be), who have not served as member of BOG, in any capacity, are to be proposed. Any one from amongst the panel of the three names shall be nominated by the Senate as BOG member.
- (iv) One Associate Professor or an Assistant Professor shall be nominated alternately for one tenure, i.e. if an Assistant Professor was a Senate nominee for BOG, then in next turn an Associate Professor shall be the Senate nominee for BOG.
- (v) It was agreed by Senate that for better representation of the female faculty members & as per the mandate of PM of India, the Senators shall make all possible efforts to nominate at least one lady faculty member to the BOG, if the name of the female faculty-member is amongst the panel of the three faculty-members.
- (vi) It was also approved that of the panel of the three faculty-members, the two faculty-members who are not nominated in a term shall be duly considered along with one more faculty-member in seniority, during the nomination for the next tenure in both the panels.
- (vii) Senators approved that keeping in view the fag end of service of the faculty members who are having nearly one year/retiring in 2021, not to be considered for nomination.

Based on the adopted guidelines as recommended in 18th SCOS & notified vide Notification No. NIT/HMR/Academic/363/2020/27792-27807 dated 03/08/2020 and incorporating the above suggestions ((i) to (vii) of **Sr. No. 16** of SENATE/MIN/33/2020-08/04 (A) (i), the following two panels were proposed:

The case of the above 05 nos. of Research Scholars namely (i) Ms. Archana Thakur (Registration No. 2K15-Ph.D-Chem-297) (ii) Ms. Kirna Devi (Registration No. 2K15-Ph.D-Chem-296) (iii) Mr. Nishant Sharma (Registration No. 2K15-Ph.D-CSE-298) (iv) Mr. Sachin Kumar (Registration No. 2K15-Ph.D-Math-287) and (v) Mr. Ashok Kumar (Registration No. 2K14-Ph.D-Phy-269) was deliberated in the respective Department Doctoral Programme Committee (DDPC) and recommended for extension of Ph.D Programme, as their work has been delayed due to COVID-19 pandemic. The Clause No. 11.1.2 provides that maximum extension upto two years can be given by the Senate on the recommendations of DDPC and SDPC as a special case in blocks of one/or for full two years at a stretch. Thus the SDPC recommends the case for one year extension to these Research Scholars.

- a) A minimum of 80% marks/ 8.5 CGPI in the master degree in Geology/Applied Geology/Earth Science or an allied area in case of Open/EWS/OBC-NCL category. Whereas, in case of SC/ST candidates, a minimum CGPI of 8.0 on a 10 point scale (or equivalent) or 75% marks in master degree in Geology/Applied Geology/Earth Science or an allied area along with a Valid GATE score or CSIR/UGC NET/NBHM.
- b) The course work requirement shall be governed by the clause 11.11 of doctoral ordinance as applicable for the candidates having bachelor degree in engineering or architecture.

Decision:

After detailed deliberations, the SENATE approved the recommendation as under regarding adding the eligibility criteria for admission to Ph.D. programme in Geology:

- i). The Senate approved the first part i.e. "Bachelor degree and Master degree in Engineering/Technology in the appropriate discipline." (other existing conditions remaining same)"
- ii). For the proposed criteria under OR, the Senate approved that a committee shall be constituted to relook into this criteria in light of the proposed New Education Policy, so that the same may be uniformly extended to other programmes as well.

SENATE/MIN/33/2020-08/T-2: PhD admission in the Department of Humanities and Social Science in particular and NIT Hamirpur in general for Academic Session 2020-21

The DDPC, Department of Humanities and Social Sciences has discussed the present scenario of Ph.D Admission in the Department of Humanities and Social Sciences in particular and NIT Hamirpur in general as under:

Subject included in the PhD admission of Humanities and Social Sciences held in Jan 2020 had only selected subject namely Economics, Sociology and Psychology, which is limiting the scope of research in the department	It is decided that as the faculty members are having different specializations and are working in maximum areas of Behavioural and Social Sciences, hence while advertising the PhD admission the specialization should not be limited to some subjects only, but the scope should widen to all the subjects of Behavioural and Social Sciences. Hence, it is recommended that PhD admission in the department should be advertised as Behavioural and Social Sciences.
2.	PhD Admission in the Department of Humanities and Social Science in particular and NIT Hamirpur in general for academic session 2020-21.	It was discussed that that as the majority of NITs and IITs are admitting PhD Students for academic session 2020-21. Hence, it is recommended that NIT Hamirpur should also start the PhD admission process at the earliest.

Decision:

The SENATE approved the recommendations of DDPC, Department of Humanities and Social Sciences and decided that in addition to the existing clause No. 4.3.3 of the Ordinances for Doctoral Programmes, as eligibility for PhD admission, the subject Behavioural and Social Sciences shall also be added along with the other subjects mentioned in the clause for the admission eligibility criteria in the Department of Humanities and Social Sciences.

Representations of Research Scholars admitted for PhD programmes under FT02 category (without scholarship) were received requesting to convert their category to FT01 or provide some financial assistance to them keeping in view the financial condition of their family.

Decision:

The Senate approved that FT02 category of PhD Research Scholars can't be converted to FT01 in accordance with Ordinances for Doctoral Programmes. However, it was further decided by the Senate that the Research Scholars, who are admitted in PhD programmes under FT02 category (without fellowship), the provision of Teaching Assistanceship shall be made, for which, the committee is already constituted to frame the guidelines for placing the matter in FC/BOG. The report of the Committee shall be placed in the forthcoming meeting of Senate.

The Senate also approved to modify the Clause 4.2.1 (ii) by including the words "or Self-financed" as follows:

Quetto

Self-financed Research Scholars (Category Code: FT02)

These scholars shall receive fellowship from other agencies such as UGC, CSIR, DST, etc. or Self-financed, at their own level.

SENATE/MIN/33/2020-08/T-4: Re-establishing the Centre for Energy and Environment

During the discussions in the Senate meeting, it was apprised that a committee has been constituted to re-establish the Centre for Energy and Environment Engineering, NIT Hamirpur HP, keeping in view the huge demand for Renewable Energy and Environment in present scenario and the numerous representations/emails received from the various stakeholders, students and Alumni.

Decision:

The committee shall prepare its report and place the same for deliberations in the forthcoming Senate meeting.

No comments were received within the stipulated time period. The Institute can implement such decision of the Senate, accordingly.
