NOTIFICATION

Sub: Suspension of on-campus activities and resumption of limited academic activities through online mode.

In continuation to Office Order No. NIT/HMR/Admn./COVID-19/575/2020/2748, dated 13.04.2020 and other notifications issued earlier (Nos. NIT/HMR/D/ 24-28, dated 14.03.2020&NIT/HMR/Admn./F-16/2020/2551-80, dated 17.03.2020, Notification No. NIT/HMR/Admn./COVID-19/575/2020/2703-32 dated 20.03.2020 and NIT/HMR/Admn./COVID-19/575/2020/2742, dated 26.03.2020) in this matter, it is to notify all concerned that:

In view of continuing onslaught of COVID-19 pandemic in the country and while ensuring life safety of students, following guidelines will be observed regarding functioning of the Institute:

- On-campus academic and research activities for all UG, PG and PhD students will continue to remain suspended in the Institute till formal notification is made regarding resumption of class work.
- The offices of the various Departments/Sections may be opened on all working days w.e.f. 22nd May, 2020 in the first half only (from 10.00 AM to 02.00 PM) at the discretion of concerned Head of the Department/Section. Head of the Department/Section shall ensure that no work is left unattended.
- 3. Academic Departments will be opened for administrative purposes only as mentioned above, as and when required, as per the timing mentioned above, while maintaining the minimum required presence of the employee. Non-Faculty members of the Department will be required to attend as per requirement and directives of the concerned Head of the Department.
- 4. However, no student shall be allowed to enter the Department/Section/Hostel and no academic/research activities involving student(s) be permitted (inline with Ministry of Home Affairs guidelines regarding the educational institutions).
- 5. The Head of the Departments/Offices/Sections may call regular staff as well as those provided through outsourcing agency, etc. to perform various activities as and when required.
- 6. These instructions are not applicable to the staff and Departments/Sections covered under essential services, where 100% attendance is compulsory except for the persons coming from Containment Zones.
- 7. All staff and campus residents are advised to strictly follow the guidelines of Ministry of Health Affairs, Government of India and advisory of District Administration (Hamirpur, HP) from time to time.

8. Outsourced workers and all employees of other entities/vendors in the campus must follow the same guidelines as suggested for campus residents.

The above arrangement shall be effective from 22nd May, 2020 and will remain in force till further notification in this regard, and will be reviewed periodically and updated depending on the guidelines and order issued by the authorities in this regard.

9. Students who are currently away from Campus will remain at their respective places and can return to the Institute only after formal announcement regarding resumption of class work. However, few students related academic activities will be pursued through online mode as per detailed notification issued from time to time by Academic section.
