
Sub: Suspension of in-campus activities, Learning through Online Platforms and Re-Scheduling of Summer Vacations

In continuation to office Order Nos.NIT/HMR/D/ 24-28, dated 14.03.2020&NIT/HMR/Admn./F-16/2020/2551-80, dated 17.03.2020,Notification No. NIT/HMR/Admn./COVID-19/575/2020/2703-32 dated 20.03.2020 and NIT/HMR/Admn./COVID-19/575/2020/2742, dated 26.03.2020, it is to notify all concerned that:

1. In light of current COVID-19 situation in the country, all in-campus students' related activities (including academic and research) for U.G., P.G. and Ph.D. students will continue to remain suspended till **31st May, 2020**.
2. Summer Vacation for students will now be from **16th April, 2020 to 31st May, 2020** in place of earlier notified 18th May, 2020 to 19th July, 2020 in Academic Calendar for session 2019-20.
3. For students of U.G., P.G. and Ph.D. programmes, learning through online interaction with their faculty members will continue till **15th April, 2020**.
4. For faculty members, the **Summer Vacations** and **Work from Home** period will be as follows:
 - Optional Summer Vacations from 17th March, 2020 to 31st March, 2020 except Heads, Deans, Associate Deans, Chief Warden & Wardens.
 - Work from Home from 1st April, 2020 to 15th April, 2020 for all faculty. They were requested to interact with their associated students through on-line platforms.
 - Optional Summer Vacations from **16th April, 2020 to 31st May, 2020** for all faculty except Heads, Deans, Associate Deans, Chief Warden, Wardens & Assistant Wardens, FI (CC) and faculty engaged in academic matters.
 - All faculty members are advised to be in continuous touch with their UG Project students, PG Dissertation students and Ph.D. research scholars through online mode.

- All HODs are advised to be in continuous touch with students of their department through Class Representatives (CRs) and guide them regarding academic involvement through various academic online platforms during vacation period from 16th April, 2020 to 31st May, 2020.
5. All academic activities of all UG, PG & Ph.D. students are expected to resume from **1st June, 2020** subject to review of COVID-19 situation in last week of May, 2020. Notification in this regard shall be issued accordingly.
 6. The non-teaching staff members (except officer cadre/section head) will Work from Home and may be called on phone as per need except staff engaged for essential services such as Medical, Security, Housekeeping, Water Supply, Electric Supply, Internet.
 7. All campus residents are advised to strictly follow the guidelines of Ministry of Health Affairs, Government of India and advisory of District Administration (Hamirpur, HP) from time to time.
 8. Outsourced workers and all employees of various other entities/ vendors in the campus must follow the same guidelines as specified for campus residents.
 9. All Faculty, Students and Staff are advised to check the Institute website regularly for future updates.
