For allocation of the Institute Elective Course, all the M.Tech./MBA students, registering in 2nd semester are required to write an application and meet in person with the concerned Subject Faculty in the Department, as above, for seeking prior permission in writing, for studying a particular Institute Elective subject. The permission to study a particular Institute Elective subject shall be accorded by the concerned Subject Faculty on First Come First Served basis (FCFS) to a maximum of 50 students for each Subject, on the student's application itself while mentioning the FCFS order on it and also maintain its record. After seeking written permission, the student shall fill the details of Institute Elective on the Registration Form, which shall be duly verified by the concerned Registration Incharge of the Department. Minimum 06 number of students should opt a particular Institute Elective Course for running the same.

Note: 1. Any of the above subject(s) which a student has already studied or shall study it as his/her core subject is not to be opted by a student as Institute Elective.

2. Students who fail to seek prior permission of the concerned Subject Faculty in the Department for studying the Institute Elective subject shall not be allocated any Institute Elective subject which may result in non-registration/ semester break of 2nd Semester.

3. Students should ensure that they do **not** seek permission for more than one subject.
