- (a) The dates for online fee deposit by the selected candidates is from 19th December 2025 to 5th January 2026 and reporting in the concerned Department/ Centre for 1st semester registration is 5th January 2026.
- (b) In case selected candidates fail to deposit the fee and register for 1st semester on 5th January 2026, then his/her seat shall stand cancelled automatically and seat may be offered to the candidate from the Waiting List, as per merit, if any.
- (c) The Head of the concerned Departments/Centre shall, in time bound manner, issue the Letters to the above selected candidates informing them about their selection and other necessary information regarding fee deposit, reporting to Institute, physical verification of Original Documents, etc. as per the Information Brochure of Ph.D. Admission of Jan. 2026.
- (d) The Heads of the concerned Departments/Centre shall ensure physical verification of the Original Documents of the selected candidates before their joining the Ph.D. Programme in the Department/ Centre and the complete personal Files, with attested copies of all relevant documents placed in sequence, of all the Ph.D. Scholars joining the Institute (including the waitlisted candidates, if any) is required to be forwarded to the Office of the Dean (Academic), by the concerned HOD, by 15-01-2026.
- (e) The allocation of Supervisor shall be in accordance with the Institute Policy for PhD Supervisor allocation.
- (f) The Head of the Departments/Centre shall allocate the Registration Numbers to the selected candidates. For example, in the Civil Engineering Department the allotment of Registration Nos. shall begin with 26RCE001 and so on.

Note: * At the time of reporting for 1st Semester registration in the Department/ Centre, the above candidates have to mandatorily produce all required documents with regard to their eligibility, category, etc. in the Department for verification and also submit the <u>self-attested</u> copy of every document, failing which their admission to PhD programme shall stand cancelled automatically. The Migration Certificate is required to be submitted in original.
