### 3. Supporting Documents

- Candidates must attach scanned copies of all relevant supporting documents with the application.
- The candidate must provide a certificate/document from the concerned University for conversion of CGPA/CPI to equivalent percentage (%), wherever applicable.
- At the time of interview, candidates must produce original certificates/testimonials for proof of Caste, Age, Educational Qualifications, B.E./B.Tech/M.E./M.Tech mark sheets, and No Objection Certificate (if applicable).
- One set of self-attested photocopies of all the above documents must be submitted at the time of interview.
