## महत्वपूर्ण निर्देश (IMPORTANT INSTRUCTION)



1. इच्छुक एवं पात्र अभ्यर्थियों को निर्धारित आवेदन पत्र (परिशिष्ट-1) विधिवत् भरा हुआ, अपनी शैक्षणिक योग्यताओं से संबंधित सभी उपाधियों, प्रमाण-पत्रों एवं अंकतालिकाओं की स्वप्रमाणित छायाप्रतियों सहित ई-मेल के माध्यम से भेजना अनिवार्य है।

Interested and eligible candidates must email the duly filled prescribed application form (Annexure 1) along with self-attested photocopies of all degrees, certificates, and mark sheets related to their educational qualifications.

2. सभी संक्षिप्त सूचीबद्ध आवेदकों को व्यक्तिगत साक्षात्कार के समय अपनी शैक्षणिक योग्यताओं एवं अनुभव से संबंधित सभी मूल प्रमाण-पत्र (केवल हार्ड कॉपी में) प्रस्तुत करना अनिवार्य होगा। इनके अभाव में उन्हें व्यक्तिगत साक्षात्कार में सम्मिलित होने की अनुमति नहीं दी जाएगी। व्यक्तिगत साक्षात्कार में उपस्थित होने हेतु किसी भी प्रकार का यात्रा भत्ता/दैनिक भत्ता (TA/DA) देय नहीं होगा।

All the shortlisted applicants shall be required to bring all their Original Certificates of educational qualifications and experience (in Hard Copy only) at the time of personal interview without which they shall not be allowed to appear in personal interview. No TA/DA shall be paid for attending the personal interview.
