

TERMS AND CONDITIONS:-

1. Postal Instruction: Quotations addressed to the undersigned may be sent on Letter Head Pad Of the firm as per schedule notified in quotations in sealed envelopes super-scribing the items of the offer and the date of opening. Offers/quotations received through electronic mail or fax will not be considered.
2. Submission of original documents: The bidders are required to submit (a) original technical documents in the O/O Executive Engineer, NIT, Hamirpur as specified with the quotation in the separate envelope.
3. Price/Rate: The price of the material may be quoted in Indian rupees & inclusive of all taxes as per Govt. of India notification.
4. GST: All the firms may invariably mention their GST numbers on quotation, failing which quotations may not be considered valid. Further, this Institution does not issue any C/D Concessional form, so the GST applicable as per actual rates must be mentioned in the offer. In case GST is not mentioned, the rates shall be treated as inclusive of all taxes.

5. Validity: Minimum validity of the quotation will be 03 months from the date of opening of the quotation.
6. Right of Acceptance/Rejection: Right of acceptance and rejection of any quotation in part or full without assigning any reason are reserved with the institution authorities.
7. **The firm must have successfully completed either one work of identical nature with a value equal to or exceeding the tendered amount or two works of identical nature each with a value of at least 50% of the tendered amount, in any Central/State Government Organization, Public Sector Undertaking (PSU) or Corporate Sector. Copies of recent and relevant work orders along with corresponding completion certificates must be submitted with the quotation as proof of experience.**
8. The firm's invoices may be prepared after successful completion of work, following the submission of a certificate from the Institute's Joint Inspection Committee confirming the satisfactory completion of services during the respective quarter.
9. **The firm/contractor must have a valid "A" Class Electrical License duly issued from License issuing authority.**
10. **The material to be used shall strictly conform to the prescribed specifications and must be approved by the Engineer-in-Charge prior to commencement of the work.**
11. The firm has to provide the Moisture Content Test (Water Content), Dielectric Strength Test (Breakdown Voltage Test of oil pre and post the dehydration process).
12. Any dispute arising during the execution of work, including but not limited to labor accidents, shall be settled by the contractor at their own level and cost. NIT shall not be held responsible for any such disputes.
