1. Introduction and Invitation for Proposal -

National Institute of Technology Hamirpur, (here-after called NITH), has been appointed as Nodal agency by DDMA (District Disaster Management Authority) Hamirpur for the conduct of State Sponsored "Scheme for Training of Masons, Carpenters and Bar Binders on Hazard Resistant Construction" in the district. The training program is designed to develop the capacities of masons, carpenters and bar binders in promoting disaster-resistant construction practices, especially earthquakes. Thus, Residential Training Facility (Training Infrastructure, Boarding & Lodging, Mobilization, Training Management, Documentation, Post Training Mobilization) is required near the institute (within 25 km) for the training with a capacity to accommodate 50 masons (considering two training batches running parallel in the facility).

The empanelment shall be valid initially for 1 year and may be extended to one more year based on satisfactory services rendered and at the discretion of the Director, NIT Hamirpur on recommendation of PI.

2. EOI-BIDDING SCHEDULE

3. TRAINING DURATION AND BATCH SIZE

The Training shall be conducted for 6 days, preferably in batches of two (consisting of around 25 masons in each batch), the training schedule will be shared based upon the mobilization of participants by the empaneled organization. The training program will be a minimum of 6 teaching hours a day, excluding registrations, refreshments, tea, and lunch. Training(s) may also be conducted on Saturday(s) / Sunday(s) / holiday (s) along with weekdays as well. The experts shall be arranged by NITH


4. Physical Criteria and Administration Support

For the submission of bids, the firm must have below mentioned facilities and services : -

- a. At least 2 training halls in ready conditions with a minimum seating capacity of 25 participants in each hall.
- b. Residential rooms in good and properly ventilated condition with a capacity to accommodate at least 50 masons with CCTV cameras installed for monitoring purposes. Not more than 3 masons should be accommodated in a single room.
- c. A Separate and clean Kitchen along with sufficient cooking and catering staff.
- d. Availability of Dining Hall for a minimum of 60 persons (including Guest Speaker/ staff etc.) with the availability of clean and purified water arrangements.
- e. Availability of materials like cement, sand, aggregates, reinforcement, bar cutter machine, masonry tools, etc. for practical training of Hazard resistant construction.
- f. Availability of proper open space for organizing at least 2 parallel practical training sessions.
- g. Availability of proper storage space for the training material of Mason Training Programs (50 sq. feet)
- h. Ample number of clean & hygienic toilets and bathroom facilities (at least one toilet and bathroom for 3 masons). An adequate number of water geysers/hot water facilities may also be available.
- To ensure safety protocol, wellbeing of participant and availability of a First Aid kit and a vehicle for dealing with any eventuality.
- j. To ensure documentation of the trainee i.e. registration / identity documents / attendance
 / feedback etc. and maintain the digital database of the same thereto.
- k. Three meals including breakfast, lunch, and dinner to each mason for at least 6 days or as directed by the authorities (depending upon the batch size and availability of masons) are to be provided/supplied by the successful empaneled agency. In addition to the same, the provision of tea with some snacks is also to be arranged.
- To provide at least 4 on-roll experienced Management Staff for organizing successful training including 2 documentation/ communication assistants and 2 maintenance/ service staff.
- m. To assist the institute/ DDMA, Hamirpur Office in organizing training and mobilization of trainees as per the training requirements.

5. Technical Eligibility Criteria

The proposers should meet the minimum pre-qualification criteria. Offers from proposers who fail to meet the following minimum eligibility criteria shall be summarily rejected and will not be considered for further evaluation.











7. EVALUATION OF PROPOSAL

The proposals shall be evaluated, and selection will be based on technical, and financial criteria. A committee set up by the Director, NIT Hamirpur will evaluate the EOI submitted on the scheduled date and time. During proposal evaluation, the committee set up by the Director, NIT Hamirpur may ask the proposer for clarification of its proposal. The request for clarification and the response shall be in writing and no change in the price or substance of the proposer shall be sought, offered, or permitted. The evaluation process shall be conducted in the phases as under: -

- i. Phase-I Evaluation of the technical criteria of the firms applying for empanelment based on documents detailed in clause 6a of this document, shall be followed.
- ii. Phase-II -PI of Project / DDMA (Hamirpur) may conduct a site visit to assess/authenticate the Physical Criteria and Administrative support as stated in section 6 of this document.
- iii. Phase-III The financial bids as per clause 6b of this document shall be evaluated only for those firms which are technically qualified.
- iv. Funds amounting to Rs 4,000/- per training for the procurement of training material and miscellaneous expenses respectively shall be paid additionally to the empaneled firm.
- v. Bid proposal will remain valid for the 120 days from the date of its opening.
- vi. The EMD of unsuccessful bidders will be returned after the EOI process is finalized, the EMD of successful bidder will be returned after the submission of required PBG
- vii. The selected Training Organizations/Institutes/Firms/NGOs/Registered Societies etc. shall be required to furnish Performance security @ Rs 27,000/- (Rupees Twenty-Seven thousand only) at the award of empanelment. Such security shall be furnished in the form of an Account Payee Demand Draft or duly pledged Fixed Deposit Receipt or Bank Guarantee from the bank, in favor of Director, NIT Hamirpur at Hamirpur for a period not less than one year from the award of empanelment.
- viii. PBG of the firm / bidder must be valid upto the 3 months after the contract completion date and it will be returned to the firm on completion of all codal


