
- (a) The date for fee deposit and 1st semester registration of selected candidates in the respective Departments/ Centre shall be **1st July 2025**.
- (b) In case selected candidates fails to deposit the fee and register for 1st semester on **1st July 2025**, then his/her seat shall stand cancelled automatically and seat may be offered to the candidate from the Waiting List, as per merit, if any.
- (c) The Head of the concerned Departments/Centre shall, in time bound manner, issue the Letters to the above selected candidates informing them about their selection and other necessary information regarding fee deposit, reporting to Institute, physical verification of Original Documents, etc. as per the Information Brochure for Ph.D. Admission of July 2025.
- (d) The Heads of the concerned Departments/Centre shall ensure physical verification of the Original Documents of the selected candidates before their joining the Ph.D. Programme in the Department/ Centre and the complete Personal Files, with attested copies of all required documents (as per point 6 of the Information Brochure) placed in sequence along with duly filled Academic Registration Form DPP-01 in respect of all the Ph.D. Scholars joining the Institute (including the waitlisted candidates, if any) is required to be forwarded to the Office of the Dean Academic, by the concerned HOD, upto **14-08-2025**.



- (e) The allocation of Supervisor shall be in accordance with the Institute Policy for PhD Supervisor allocation.
- (f) The Head of the Departments/Centre shall allocate the Registration Numbers to the selected candidates. For example, in the Civil Engineering Department the allotment of Registration Nos. shall begin with 25RCE005 and so on if the Roll Nos. upto 25RCE004 have already been allocated during PhD Admissions of January 2025.
- (g) If at any stage it is found that any applicant has concealed/ misrepresented or supplied deficient information at the time of application, then his/her candidature/admission shall be summarily rejected.

Note:

- (i) At the time of reporting for 1st Semester registration in the Department/ Centre, the above candidates have to mandatorily produce all required documents with regard to their eligibility, category, etc. in the Department for verification and also submit the self-attested copy of every document, failing which their admission to PhD programme shall stand cancelled automatically. The Migration Certificate is required to be submitted in original.
- (ii) The candidates whose final result is awaited shall be allowed to provisionally register for 1st semester subject to submission of an undertaking that he/she shall submit the Final Semester Result/ proof of having passed the qualifying Examination, as per the eligibility criteria, by 13th August 2025, failing which his/her provisional admission to PhD programme shall stand cancelled automatically and no fee shall be refunded.


