Pursuant to the approval of the Competent Authority, the list of candidates selected for admissions to Ph.D programmes in the Institute through the Ph.D admission process for July, 2026 is as per enclosed Annexure-I:-

- The dates for online fee deposit by the selected candidates is from **13th July, 2026 to 20th July, 2026** and reporting in the concerned Department/Centre for 1st semester registration is 20th July, 2026.
- In case selected candidates fail to deposit the fee and register for 1st Semester on **20th July, 2026**, then his/her seat shall stand cancelled automatically.
- The Head of the concerned Department/Centre shall, in time bound manner, issue the letters to the above selected candidates informing them about their selection and other necessary information regarding fee deposit, reporting to Institute, physical verification of Original Documents, etc. as per the Information Brochure of Ph.D. Admission of July, 2026.
- Head of concerned department shall ensure that the candidates appearing in the qualifying examination must be issued a provisional admission letter stating clearly that the candidate must fulfil the required eligibility criteria by 30th september 2026 failing which their provisional admission shall stand cancelled and the semester fee (except caution maney) shall be forfeited. Head of department must submit the report/document of all such provisionally admitted candidates by first week of October 2026.
- The candidates have to mandatorily produce all required documents in original with regard to their eligibility, category, etc. in the respective department for verification and also submit the self-attested copy of every document before their joining the Ph.D. Programme, however, the Migration Certificate is required to be submitted in original. The Heads of the concerned Departments/Centre shall ensure physical verification of the Original Documents of the selected candidates in the respective department/Centre and the complete personal files, with attested copies of all relevant documents placed in sequence, of all the Ph.D. Scholars joining the Institute is required to be forwarded to the Office of the Dean (Academic), by the concerned HOD, **by 23/07/26**.
- The allocation of Supervisor shall be in accordance with the Institute Policy for PhD Supervisor allocation.
- The Head of the Departments/Centre shall allocate the Registration Numbers to the selected candidates. For example, in the Civil Engineering Department the allotment of Registration Nos. shall begin with 26RCEXXX in continuation with the earlier assigned roll number in 2026.
