- Online sealed tender in two bid system on form 6 & 8 are hereby invited by the undersigned for the following work on behalf of the Director, NIT, Hamirpur (HP) from the Approved/ Eligible/, Firm/Contractor who are registered with C.P.W.D, H.P.P.W.D., MES, Railways, State PWDs, H.P.S.E.B.L, Urban Development Authorities , Industrial Infrastructure Development Corporations and Housing Boards having experience in appropriate field and valid enlistment certificate issued from above Govt. organizations and who have successfully completed works of similar nature. Hard copy of dully filled, signed and stamped tender documents should reach in the office of the undersigned as per date & time mentioned below:-

- Availability of bid document and mode of submission:-The bid document is available online and bid should be submitted in online mode on website <http://www.eprocure.gov.in/> and <http://www.nith.ac.in/>. Bidder would be required to register in the web-site which is free of cost. For submission of bids, the bidder is required to have digital Signature certificate (DSC) from one of the authorized certifying authorities (CA).

- (II) Objections/representation if any against the bidders will be entertained only within three days after publication/uploading of technical bid opening summary on website <https://eprocure.gov.in/eprocure/app/ CPP Portal> and there after that the date of opening of financial bid of technically qualified bidders will be published /upload on website/ CPP Portal.
- Tender Details:-The tender Documents shall be uploaded in 2 cover:-
Cover 1:-Shall contain scanned copies of all "Technical Documents/Eligibility information".
Cover 2:-Shall contain "BOQ/Financial Bid", where contractor will quote his offer for each item.
- Submission of Original Documents: The bidders are required to submit (a) original bid security/Earnest Money deposit (EMD) and other technical documents in the O/o Executive Engineer, NIT, Hamirpur as specified in the key dates at Sr. No. 4 above on tender opening dates & schedule, failing which the bids will be declared non-responsive. **EMD in the form of FDR must be pledged in the favour of Registrar, NIT Hamirpur-177005. The EMD should remain valid for a period of 365 days which ever applicable beyond the date of submission of tender.** EMD of unsuccessful bidders will be returned after the expiry

of the final bid validity or before the 30th day of the award of work. The above condition is applicable to all & no relaxation will be given.

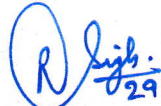
7. The contractor should produce the verification of EMD from the concerned bank, whether it is pledged in favour of Registrar NIT Hamirpur or not.
8. **BID OPENING DETAIL:-** The bids shall be opened as per schedule specified in the key dates of **Sr. No. 4** in the Office of Executive Engineer, NIT, Hamirpur in presence of Tender Opening Committee. The bidders are advised to present along with original documents at the time of opening of tenders in their interest. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time & venue.
9. The bids for the work shall remain valid for acceptance for a period of 90 days after the bid opening. Other details can be seen in the bidding documents. The officer inviting tender shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidder of any bid updates. The Employer shall not be liable for any information not received by the bidder. It is the bidders responsibility to verify the website for the latest information related to the tender.
10. **The copy of enlistment & renewals, copy of PAN issued by Income tax Department, copy of Aadhaar Card and copy of GST registration Certificate must accompany in cover-1.**
11. **Rates:-** Rates of items may be quoted as per BOQ including GST in Indian currency. Tender will be awarded to the participating bidder who will be lowest in terms of total of all items and as per comparative statement.
12. **The contractor has to hand over the clear site (site clearance) free from debris or any waste generated at site during execution to the concerned Junior Engineer after completion of work.**
13. To execute the electrical work, the contractor should provide the valid electrical license of the Associate Contractor.
14. The successful bidder will submit a Performance Guarantee @3% (Three Percent) along with verification of concerned bank of the awarded amount within 07 days after signing the agreement as per provisions contained under Clause 5.2 of CPWD Manual.
15. **Eligibility Criteria:-**
The bidder must have successfully completed at least one similar work of value not less than estimated cost of this work or two similar works each of value not less than 50% estimated cost of this work or three similar works each of value not less than one third of the estimated cost of this work.
16. **The bidders shall have to produce supporting documents of Govt. organization giving date of award, date of commencement and completion from the concerned competent authority (Rank not less than Executive Engineer) and should be included in cover-1.**
17. **Quality Assurance:-**
 - (i) Material as per theoretical consumption will be deposited before start of work.
 - (ii) The successful bidder has to deposit the material at NIT, Hamirpur as per quantity of works mentioned in the BOQ, before start of work.
 - (iii) The successful bidder has to provide Material Testing Certificates of paint material for specified lot supplied for the works from the manufacturer.
 - (iv) The sealed samples of paint material will be sent to outside laboratory of NIT, Hamirpur (Civil Engineering Department) for testing of material i.e. VOC contents, viscosity etc. and the cost of testing will be borne by the contractor/agency.
18. **Inspection of works:-**

Inspection of ongoing painting works will be carried out by the Engineer In-Charge with concerned technical staff, to ensure the workmanship and finishing of works which includes the followings:-

 - (i) The agency/contractor has to ensure the inspection of painting works at every stage.
 - (ii) **Scraping of surface-** The inspection team will conduct the inspection to ensure the proper scraping of surface. After the satisfactory scraping of surface as specified in the BOQ, the contractor/agency will be allowed to start the second stage of works.
 - (iii) **Putty works-** The inspection team will conduct the inspection to ensure the proper putty works. After the satisfactory putty works as specified in the BOQ, the contractor/agency will be allowed

to start the third stage of works.

- (iv) **Painting works**-The inspection team will conduct the inspection to ensure the proper painting works. After the satisfactory painting works as specified in the BOQ, the contractor/agency will be allowed to start the second coat of painting for final finishing.
19. **LIQUIDATED DAMAGES(LD):-**In the event of the seller's failure to submit the Bonds/Guarantees/ Documents or/and supply/perform the items/services as per Delivery schedule specified in the contract, the Buyer may, at his discretion, withhold any payment until the completion of the contract. The buyer may also deduct LD to the sum of 0.5% of the contract price of the delayed/undelivered stores/ services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages being not higher than 10% of the value of delayed stores/services.
20. **CANCELLATION OF THE CONTRACT**
NIT, Hamirpur shall have the right to terminate the Contract, arising out of finalization of this tender, in part or in full in any of the following cases :-
- The delivery of the material or start of works is delayed for causes not attributable to Force Majeure for more than 10 days after the scheduled date of delivery.
 - When both parties mutually agree to terminate the contract.
21. The financial Bid of those Bidders will only be opened whose technical bid will be approved by the Tender Opening Committee constituted for the purpose.
22. Conditional/ telegraphic tenders shall summarily be rejected.
23. The tender/bid shall be kept in a sealed envelope super scribed as "Tender for (Name of work and date of opening_____".
24. The jurisdiction of the law of Court shall be at Hamirpur (HP).
25. The rates should be inclusive of all service charges including Building Cess, Water Charges & GST etc. as per Govt. of India notification and should be quoted both in words & figures.

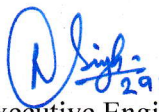
