Notice

It has come to the notice of the Authorities that certain Day Scholars, who have been issued vehicle permissions vide No.NIT/HMR/DSW-205/2025/1581-87 Dated 27/03/25, are using their vehicles in undesignated areas of the campus, despite the fact that vehicle permission to Day Scholars was granted solely for commuting only.

Consequent upon the meeting held with Associate Dean (SD&C), Associate Dean (SA&S), FI- Student Discipline and FI- Security, and in order to ensure the **safety, security and welfare of students as well as residents**, the following guidelines regarding the movement and parking of vehicles by Day scholar inside the campus are hereby being issued and shall be strictly followed henceforth:

1. Hostel residents are strictly prohibited from possessing or using any personal vehicle within campus areas.
2. Ph.D. scholars shall be permitted to use a vehicle on the recommendation of their Supervisor and the concerned HoD/HoC.
3. **Entry and exit of Day-scholar vehicles shall be through Gate No. 1 only.**
4. Vehicles shall be parked only at designated parking areas, i.e. "New Computer Centre, near Guest House" or other parking area specifically marked/designated by the Establishment Officer/FI (Security) in consultation with this office.
5. Only vehicles for which valid permission has been granted shall be allowed inside the campus.
6. Students who have been expelled from the hostel or who have denied to stay in the hostel shall not be entitled to claim a vehicle pass.
7. Students are required to keep the **vehicle Permission letter/Gate pass (In Original) along with the Institute ID card** in their vehicle at all times and shall produce the same before the Security Guards whenever asked to do so.
8. **Any violation of the above-mentioned terms and conditions shall result in the immediate cancellation of the vehicle permission with immediate effect.**
