Sh. Nand Lal Sharma was born on 12th February 1964 in village Dohak, district Bilaspur, Himachal Pradesh in an agrarian family. He has done his schooling from Kohdra, ShahTalai and Lathiani schools. He is an alumnus of Dr Y S Parmar University of Horticulture & Forestry Nauni, Solan, HP Krishi Vishwavidyalaya, Palampur and MBA from International Centre for Promotion of Public Enterprises (ICPE), University of LUBLIANA, Slovenia (Europe).

Sh. Nand Lal Sharma started his career as an officer with the coveted Himachal Pradesh Administrative Services in 1989.
