ORDER UNDER SECTION 34 OF THE DISASTER MANAGEMENT ACT 2005

In continuation of the Orders No./DCH/RELIEF/DMC/2022-100 dated 10.01.2022 and No.DCH/RELIEF/DMC/2022-133 dated 16.01.2022 that were issued by District Magistrate for effective control of COVID-19 in the district and in compliance of Order no Rev (DMC) (C) 20-2/2022 -COVID19-IV dated 24.01.2022 issued by Chief Secretary cum Chairperson, State Executive Committee, I, Debasweta Banik (IAS) Chairperson DDMA -cum-District Magistrate, Hamirpur exercise of the powers vested in me under section 34 of Disaster Management Act 2005 hereby directs that, all the directions issued by undersigned in above mentioned orders will continue to remain in effect till **6AM of 31st January 2022**

For Himachal Pradesh Statehood Day (25th January) and Republic Day (26th January) related programs scheduled in the district, the limit for gatherings in open spaces/outdoor areas is however allowed up to 50% of the capacity ensuring strict adherence to the COVID-19 safety protocols and COVID Appropriate Behavior.

Compliance to this order shall be ensured by the Superintendent of Police, Hamirpur, all Sub Divisional Magistrates, Hamirpur, Chief Medical Officer, Hamirpur, all Executive Magistrates, Hamirpur, all Block Medical Officers, Hamirpur and public at large.

Penal Provisions:

Any person violating these measures and not following COVID appropriate behavior will be liable to be proceeded against as per the provision of Section 51-60 of the Disaster Management Act, 2005, besides entailing legal action under Section 188 of the IPC, and other legal provisions as applicable.

This order shall remain in force, in all parts of district Hamirpur till 6AM of 31st January 2022.
