**ORDER UNDER SECTION 34 OF THE DISASTER MANAGEMENT ACT 2005**

In partial amendment to this office order no. DCH/RELIEF/DMC/2022-100, dated 10<sup>th</sup> January, 2022 and in compliance to the directions passed by the Chief Secretary-cum-Chairperson, State Executive Committee, Himachal Pradesh on dated 14<sup>th</sup> January, 2022, I, Debasweta Banik (IAS), District Magistrate, Hamirpur (Himachal Pradesh) in welfare of the public at large and in exercise of the powers vested in me under section 34 of the Disaster Management Act, 2005 do hereby order and direct that:

1. All social/ religious/ academic/ sports/ entertainment/ cultural/ political and other congregations including marriages & funerals are permitted up to 50% of the capacity of indoor built up/covered areas, subject to maximum of 100 persons (whichever is lower) and in open spaces/outdoor areas are permitted up to 50% of the capacity, subject to maximum of 300 persons (whichever is lower). Prior permission of gatherings shall be obtained from concerned Sub Divisional Magistrates through the online portal <http://covid.hp.gov.in> and strict adherence to the Covid-19 safety protocols shall be ensured during these congregations/gatherings.
2. All Shops/Market Places/Malls within the Jurisdiction of District Hamirpur shall be permitted to remain open from 07:00 A.M. to 07:00 P.M. The directions shall be treated amended in the point no. 5 (I) of this office order no DCH/RELIEF/DMC/2022-100, dated 10<sup>th</sup> January 2022.
3. All marketplaces/malls/shops within the jurisdiction of District Hamirpur shall remain closed only on Sunday. The directions shall be treated amended in the point no. 5 (III) of this office order no DCH/RELIEF/DMC/2022-100, dated 10<sup>th</sup> January 2022.

This Order shall come in effect in all parts of District Hamirpur from 17<sup>th</sup> January, 2022 onwards. All other directions passed by the undersigned vide order no. DCH/RELIEF/DMC/2022-100, dated 10<sup>th</sup> January 2022 shall continue to be in effect till further orders.
