### NOTICE

In continuation of this office Notice of even No. 608-38 dated 11/01/2024 and subsequent Notice No. 5944-74 dated 05/07/2024, it is once again emphasised that as per Rule-18(i) (ii) of CCS (Conduct) Rules-1964, **every Government servant belonging to any service or holding any post included in Group A and Group B shall submit an annual return giving full particulars regarding the immovable property inherited by him or owned or acquired by him or held by him on lease or mortgage either in his own name or in the name of any member of the family or in the name of any other person.** Accordingly, all Group A & Group B Government servants were required to file Annual Immovable Property Return of the previous year latest by 31 January of the following year invariably. But it is regretted to point out that despite special opportunity to submit IPR's for previous year 2023 by 31/07/2024, many faculty/non-faculty staff have not submitted their IPRs so far, as a result the CVO of the institute could not issue required Vigilance Clearance as required from time to time.

Therefore, all the Faculty and Non-Faculty staff members (especially the newly appointed staff members) are hereby directed to ensure that they had submitted their Immovable/Moveable property return for previous/proceeding calendar year i.e. 2023 to the controlling office within the extended date upto 31<sup>st</sup> July, 2024 and in case any of the employee of the institute who has not complied with the ibid guidelines/instructions and / OR not submitted the Immoveable property return for the proceeding years i.e. 2023 by 31<sup>st</sup> July, 2024, may submit the required IPR by **10<sup>th</sup> October, 2024** on the prescribed format in his/her own interest to avoid denial of vigilance clearance etc. as per DoPT OM NO. 11013/17/2023-PP-A.III dated 14/07/2023.
