NOTIFICATION

In view of the declaration of NIT Hamirpur Campus as **MINI CONTAINMENT ZONE** by the local Administration vide order under section 144 Cr.P.C No. SDH/CZ/2022-01-17 dated 06.01.2022 received on e-mail on 07.01.2022 and subsequent recommendations of Dean's committee, the Academic & Administrative activities of the Institute except essential services are hereby closed in the public interest with immediate effect till the de-notification. However, all faculty and staff members shall make themselves available on phone call as and when required.

All the faculty, students, Staff & residents of the Campus are advised to adhere to the orders of District Administration strictly and avoid the risk of spreading COVID-19.

1. It is further ordered that under the circumstances ingress/egress any person or vehicle except the officers/officials vehicle on Government duty shall be Allowed in the above notified areas with the prior permission of District Administration Hamirpur
2. Further, there shall be no relaxation in curfew imposed qua any shops or banks within the entire above notified area till further orders. The essentials goods like milk, groceries, vegetables, pharmaceutical, gas supply shall be allowed in the above notified areas with the permission of District Administration Hamirpur.
3. No person shall leave their home or move on foot or by vehicles or travel or roam around or stand on any road or public places in the NIT Campus.
