**Eligibility Criteria**

1. The agency should have license/registration/ consent to operate from HP state Pollution Control Board.
2. The agency should have GST Registration No.

**Scope of works**


- i) The agency has to dispose off 25 trips truck load of minimum 2 to 2.5 ton load per trip of Garbage Solid Waste Material.
- ii) Bailing machine facility will be provided by NIT, Hamirpur, if the agency is willing to prepare the bundles of Garbage Solid Waste Material.
- iii) The agency has to arrange the transportation facility for carrying the plastic waste bundles.
- iv) The agency has to provide the weighing slip of Garbage Solid Waste Material and for truck load verification, an authorized employee from Construction cell will be deputed.
- v) The agency has to provide certificate for Garbage Solid Waste Material disposal of NIT, Hamirpur.
- vi) Bailing machine will be provided by NIT, Hamirpur in working condition and if any fault occur during the bailing process, should be restored by the agency, at his own cost.
- vii) The agency has to hand-over the bailing machine in working condition after completion of works.
