Undertaking by the Student

1. I will use face mask as well as any other prescribed protective gear and maintain social distancing in my class room/ Laboratories/ academic area/ hostels and in the campus.
2. I will regularly wash hands with soap and water for at least 20 seconds or clean with alcohol based sanitizer.
3. I will use Aarogya Setu App on my mobile and it will remain active at all times (through Bluetooth and Wi-Fi)
4. I will self-monitor my health. In case, I develop fever, cough and breathing problem then I will inform about it to Medical Officer/ Warden/ Head of Department/Centre, etc. Also I will consult a doctor and follow medical advice.
5. I have my own masks, sanitizer and a thermometer for monitoring body temperature for personal use.
6. I understand that in the hostel I have to share common washrooms, and dining facility, etc. I shall take necessary care all the time by diligently following all instructions/ notices/ protocols in the hostel.
7. I agree to clean the shared bathrooms and toilets before and after their use as per hostel protocols in order to protect myself and others.
8. I as a student understand that going out of campus after arrival in the Hostel can bring infection along with. I will not go out of campus unless unavoidable.
9. NIT Hamirpur authorities/ administration will not be responsible if I contaminate any COVID – 19 symptoms.
10. I also understand that NIT Hamirpur has only a Primary Health Care Centre and it will extend all possible facilities in case of any medical emergency. However, in case of COVID-19 infection, I may require hospitalization outside the campus for which Government laid down protocols and costs shall apply.
11. I have been vaccinated with one/two doses of COVID-19 vaccine (Covaxin/ Covishield/ -----) on the dates _____ & _____ (Vaccination Proof Attached).
12. I shall bring valid RTPCR–ve report not older than 72 Hrs if coming from within Himachal Pradesh and not older than 96 Hrs if coming from other state, while coming to the campus and get entry permit from Institute Dispensary before entering the Hostel.
13. I understand that there is always a possibility of getting infected by the virus due to the number of cases in city, state and country. I and my parents/ guardians are fully aware

of the above fact. The parents accompanying the students in the campus should also bring valid RTPCR –ve report. However, the parents shall not be allowed to enter the hostel premises.
