### NOTIFICATION

This is in supersession to the Notification No.NIT/HMR/Admn/2020/-4763-67 dated 08-08-2020. Keeping in view the present scenario arising out due to COVID-19 pandemic, as approved by the Competent Authority, it has been decided that from the month of August, 2020 onward it may not be possible to collect **Hostel and Mess Operational Charges** from the students directly by the Hostel authorities. Hence, it has been decided that Rs.5000/- (Rupees Five Thousand Only) per semester will be deducted from the mess advance of the students of UG, PG & Ph.D. presently allocated with the rooms in the various hostels. Hence, students having mess advance more than Rs.5000/- need not to deposit **Hostel and Mess Operational Charges**. However, students having mess advance less than 5000/- need to deposit Rs.5,000/- in the respective hostels where they are presently staying. This amount will be used for the payment of salary of all mess workers and other operational charges such as water and electricity bill etc. of all hostels. The advance received will be adjusted in the Mess Advance of respective students, when the hostels will become operational after fresh (new) allotment.

The **new entrants (First Year)** of UG, PG & Ph.D., students will not bear the Hostel & Mess Operational Charges (i.e. Rs.5000/- per semester) because they have not yet occupied hostels.

It has been decided that students who have already paid the **Hostel and Mess Operational Charges** as per Notification No. NIT/HMR/Admn/2020/-4763-67 dated 08-08-2020 will be refunded the same amount back.

This has been issued with the prior approval of the Competent Authority.
