Subject: Invitation of applications for Exit of Programme from Dual Degree(ECE/CSE) to B.Tech. (ECE/CSE) / B.Tech. (ECE/CSE) to Dual Degree(ECE/CSE)

Applications in the prescribed format (enclosed herewith) are invited from 6th Semester qualified Dual Degree (ECE/CSE) students having CGPI > 8.5 upto 6th semester for exit after 4th Year with a B.Tech. Degree, in accordance with Clause (A)(b) of the Notification No. NIT/H/Academic/FC/BOG/2021/38302-30 dated 05/04/2021. This exit from Dual Degree programme shall be allowed only to a maximum of 20% of the class strength of the respective Dual Degree programme on merit basis.

The 6th Semester qualified B.Tech. (ECE/CSE) students may also submit their applications for exit from B.Tech.(ECE/CSE) to Dual Degree (ECE/CSE). However, such applications shall be acted upon considering the seats available in the respective Dual Degree(ECE/CSE) programme and merit of the applicants.

The students are advised to be cautious while submitting the applications as the applications shall not be allowed to be withdrawn after the last date and the Exit of the programme shall be final and binding on the applicants.

The last date for students to submit the duly filled-in applications in the respective Departments is 12/07/2024.

The last date for concerned Departments to forward the applications with their recommendations to the Office of Dean(Academic) is 16/07/2024.

NOTIFICATION

Pursuant to the decision of 34th Senate vide Item No. SENATE/MIN/34/2021-01/T-3 and subsequent approval/ratification of Board of Governors [BOG] in its 44th meeting held on 09th March, 2021 at NITs Transit House, New Delhi vide resolution No. BOG/MIN/44/2021-03/22 as circulated vide letter No. NIT/HMR/44th BOG MIN/2021/1407-11 date 27/03/2021 respectively, the matter regarding National Education Policy-2020 [NEP-2020] and its implementation in the Institute with respect to Multiple Exit/Multiple Entry Policy is hereby notified as under:

(A) Multiple Exit Policy

(a) After successful achievement of the target, a B.Tech./Dual Degree/B.Arch./M.Tech./M.Arch./Ph.D. student may opt for the exit as under:

| SNo | Programme | Target Achieved | Award on Exit |

| 1. | B.Tech./Dual Degree* | Must have successfully passed credits ≥ 25% and < 40% of the approved Course Structure | Certificate in Engineering |
| 2. | B.Arch. | Must have successfully passed credits ≥ 25% and < 40% of the approved Course Structure | Certificate in Architecture |
| 3. | B.Tech./Dual Degree* | Must have successfully passed credits ≥ 40% and < 60% of the approved Course Structure | Diploma in specific Branch of B.Tech./Dual Degree |
| 4. | B.Arch. | Must have successfully passed credits ≥ 40% and < 60% of the approved Course Structure | Diploma in Architecture |
| 5. | B.Tech./Dual Degree* | Must have successfully passed credits ≥ 60% and < 100% of the approved Course Structure | Advance Diploma in specific Branch of B.Tech./Dua Degree |
| 6. | B.Arch. | Must have successfully passed credits ≥ 60% and < 100% of the approved Course Structure | Advance Diploma in Architecture |
| 7. | M.Tech. | Must have successfully passed credits ≥ 50% and < 100% of the approved Course Structure | Post Engineering Diploma in specific Department |
| 8. | M.Arch. | Must have successfully passed credits ≥ 50% and < 100% of the approved Course Structure | Post Architecture Diploma |
| 9. | Ph.D. | Must have successfully passed Comprehensive Examination and Accepted/Published one Journal Paper/Conference Paper/Book Chapter | Post Research Diploma |

*For Dual Degree, the credits of B.Tech./UG portion will only be used for calculation purpose The policy shall be implemented for all the existing as well as future students.

- (b) A Dual Degree student can exit after 4th year with a B.Tech. Degree. For this, he/she has to apply after 3rd year, and should have CGPI greater than 8.5, as the Course Structures are different for B.Tech. and Dual Degree in the 4th year.
 - > The policy shall be implemented for the present as well as future 3rd year students.
- (c) A B.Tech., 3rd year student can opt for entry to Dual Degree programme, if available in that branch and shall be eligible to complete M.Tech. in one year (after completion of the 4th year), subject to the condition that the total strength in Dual Degree does not exceed the sanctioned seats. The allotment shall be done on the basis of CGPI of the applicants upto 6th Semester.
 - > The policy shall be implemented for the present as well as future 3rd year students.
- (B) Multiple Entry Policy

A UG/PG/PhD student, who leaves the programme mid-way due to some unforeseen circumstances, shall be allowed re-entry into that programme in the year in which he would have otherwise continued, on the production of a valid reason.

> The policy shall be implemented for the present as well as future students.

(C) Academic Bank of Credits

In order to implement Multiple Exit and Multiple Entry policies, Academic Bank of Credits shall be established for all the students.
