#### Terms and Conditions:

- Before submission of the application, the applicant employee must ensure his/her eligibility for the post(s) he/she intends to apply as per RRs of Non-Teaching post.
- 2. The eligible applicant employee must ensure that his/her application is submitted through respective HoD/Section Head by 31/07/2023 (upto 5:30 PM) to the Registrar, NIT Hamirpur (HP).
- 3. Only those regular employees who are on roll of the Institute on the date of issue of the notice shall be eligible to apply in accordance with the RRs communicated by MoE vide letter F.No.35-5/2018-TS.III dated 4th April, 2019 and 20th February, 2019.
- 4. Employee intending to submit his/her application for more than one post has to submit separate application for each post.
- 5. Cut of date for reckoning the eligibility shall be the last date of receipt of the application.
- 6. Reservation for promotion shall be applicable as per Govt. of India norms.
- 7. Mere submission of the application(s) does not entail the employee to be promoted and the Institute reserves the right to fill or not fill any of the vacancy at any point of time without assigning any reason.
- 8. The notification is based on RRs communicated by MoE vide letter F. No.35-5/2018-TS.III dated 4th April, 2019 and 20th February, 2019 and subsequent changes, if any communicated by MoE, shall also applicable at the time of selection process for promotion.
- 9. Eligible/shortlisted candidates will be intimated about the schedule of written/trade test/skill test and / or Interview, as the case may be, according to the provisions of relevant RRs for Non-Teaching for Non-Teaching posts.
- 10. The qualifying marks for written exam is 33% and those who qualify the written exam, will be called for skill/trade test / or interview as the case may be.
- 11. Skill Test will be conducted by a Technical Committee.
