Subject:- Relaxation in eligibility criteria under Joint Entrance Examination (Main) for the academic year 2020 - 2021 in view of COVID-19 Pandemic.

Sir,

I am directed to refer to your communication No.Nil dated 20<sup>th</sup> July, 2020 vide which a proposal recommending thereby relaxation in eligibility criteria (qualifying percentage criteria) for under graduate admissions through Central Seat Allocation Board (CSAB) - 2020 was submitted to the Ministry of Human Resource Development for consideration and suitable decision.

2. For admissions in NITs and other Centrally Funded Technical Institutions, apart from qualifying the JEE (Mains), the eligibility is to secure a minimum of 75% marks in 12<sup>th</sup> Board exams or rank among the top 20 percentile in their qualifying examinations. Due to prevailing circumstances, as recommended by CSAB - 2020 it has decided to relax the eligibility criterion for admission to NITs and other CFTIs. JEE (Mains) 2020 qualified candidates will now only need to a passing certificate in class XII examination irrespective of the marks obtained.

3. Above relaxation is one time shall be applicable for the academic year 2020-2021 only. CSAB - 2020 shall follow all other conditions for admissions to under graduate programmes of NITs and other CFTIs.


