**NOTICE**

In view of meeting of Deans and Head of departments with CRs of 4<sup>th</sup> and 3<sup>rd</sup> years under Chairmanship of Director, NIT Hamirpur regarding reopening of NIT Hamirpur for physical presence of students from 11 October 2021 and thereafter approval of Competent Authority, following decisions are communicated to all concerned students for information and compliance :-

- 1) In partial modification to earlier notice no. NIT/HMR/DSW/Reopening/9859-70 dated 1/10/2021 of Institute regarding reopening of Institute for 4<sup>th</sup> year's students, mandatory condition of physical presence for 4<sup>th</sup> year students wef 11/10/2021 has been withdrawn. However willing students who want to join the campus for availing central facilities like library, labs may come to the institute from 11 October onwards subject to the condition of mandatory production of valid negative report of RTPCR test and undertaking. Classes however shall be in online mode and examination shall be in offline mode only. Schedule of reporting, examination, and registration shall be notified by Dean Academic separately.
- 2) Also for 4<sup>th</sup> year students of B.Tech and 4<sup>th</sup> & 5<sup>th</sup> year students of B.Arch, Mandatory reporting has been now made effective from 10<sup>th</sup> December 2021 i.e. students must report the campus latest by 10<sup>th</sup> December 2021 and conditions of production of negative RTPCR report and undertaking remain unchanged .
- 3) Further for dual degree 5<sup>th</sup> year students, it is mandatory to be physically present in the institute at par with M.Tech students and for those drawing stipend, it is necessary.
- 4) Hostel fees shall be charged on pro rata basis and shall be notified in due course of time at Institute website. Students who have already paid the full hostel fees, their excess fees shall be refunded in due course of time.
