It has been observed that till date Institute has received very low number of applications on the National Scholarship Portal (NSP). Hence, once again all the remaining eligible students (specifically belongs to ST/SC and OBC/EBC category) are advised to apply for scholarship (Fresh/Renewal) at the earliest, so that the same could be forwarded/recommended after due verification at Institute Level to next Level for further necessary action to avoid any unnecessarily delay/rush to the last date.

The students are also advised that:

1. Students must upload the desired documents scanned **from original ones**.
2. Valid Income Certificate of current financial year (i.e. issued from **April, 2024 onwards**) must be issued in the name of parents only by the Authorised/Competent Officer (Executive Magistrate/ Tehsildar /SDM/DC/ADC/Revenue Officer/Circle Officer etc. of the area).
3. The **print-out of application** along with self-attested documents in support of details filled in the online application must be **submitted in the office of the undersigned immediately after submission of online application, failing which the application will not be verified online by Institute.**
4. The applicants must check their status frequently to remove the objections raised by verifiers, if any.

All the students are advised to check the Institute Website/other scholarship websites/ Portals and Notice Boards on prominent places regularly for Notices issued by this office from time to time regarding scholarships & other student welfare matters.
