SCHOLARSHIP NOTICE

It is for the information of all **UG 1st year (undergraduate) students** of this Institute that Sri Badrika Ashram Cum Charitable and Social Welfare Society is awarding "Sri Badrika Ashram Emerging Youth Scholarship (पढ़ो और बढ़ो)" to bright and needy students of NIT Hamirpur. Students who fulfil the below mentioned eligibility criteria may apply for the scholarship (as per attached application format) and submit the same along with all supporting documents duly self attested and forwarded by the concerned HOD in the office of undersigned **latest by 03/10/2024 (upto 5.00 PM)**.

No application shall be entertained after due date i.e. **03/10/2024**.

Eligibility Criteria:

1. That **Sri Badrika Ashram Emerging Youth Scholarship (पढ़ो और बढ़ो)** provides of the tuition fee and academic fees for students having family income between 1 Lac to 5 Lac and only academic fees for students having family income less than or equal to 1 Lac. Hostel fees shall be considered only for students having family income less than 1 Lac and that too on case to case basis only.
2. That **Sri Badrika Ashram Emerging Youth Scholarship (पढ़ो और बढ़ो)** will be provided to the students who are enrolled as a full time student in the Institute.
3. That the eligibility to receive the award, the candidate must fulfil the following requisites:
 - a) That the candidate must be enrolled as a full time student in an undergraduate degree in the Institute.
 - b) That the candidate must be a Himachal Pradesh resident holding a Himachal Pradesh domicile. The students who are not residents of Himachal Pradesh and do not hold domicile can be considered on a case-by-case basis solely at the discretion of the Society.
 - c) That the candidate must be meritorious having scored a minimum of 65% for the BPL category and 75% for the other category in class 10th and class 12th to avail the benefit of scholarship for which signed and attested photocopies of documents must be submitted by the University.
 - d) The eligibility criteria for short listing of students to avail the scholarship shall be either of following:
 - i. Students from below poverty line (BPL) families (BPL Card is required) with minimum of 65% marks in class 10th and class 12th **OR**
 - ii. Student belonging to a family with an annual income below Rs. 3.00 lacs (Income proof Certificate from Tehsildar/SDM is required) with minimum of 75% marks in 12th grade.
 - e) In case the student belongs to d (ii) category specified above, then(s) he should belong to one or more of the following sub-categories to be eligible for this scholarship. The order of preference shall be as under:
 - i. Orphaned students
 - ii. Single parent households—mother or father are separated, expired
 - iii. Families with cases of chronic/terminal illness such as cancer etc.
 - iv. Students whose parents are engaged in manual jobs such as daily wage labourers, ex-servicemen from the Indian Armed forces.
 - v. Families with multiple daughters
 - vi. Meritorious Students who have attained more than 90% in 12th grade.
 - f) That the students shall be considered for this scholarship program on a first cum first serve basis as referred by the Institute.

- g) Among the eligible students, selection of the awardee will be done as per the Society's selection process. The Society will have complete autonomy in deciding the awardee, based on its internal selection criterion.
- h) That a student taking admission under the management quota shall not be considered for this scheme.
- i) That the total number of students from the Institute to be considered under the scheme shall be a maximum of all eligible students who meet the Society's internal selection process unless and until the Society decides otherwise.
- j) The Society's student selection process shall be in the following order:
- i. Short listing of students provided by the Institute based on the eligibility criteria below:
 - a) BPL Category
 - b) Other income category in order of lowest to highest with the order of preference as mentioned in point no. 4(e).
 - ii. An initial screening over a phone call to determine authenticity of the students' background.
 - iii. A personal interview via video call with the Society's executive team to further understand students' candidature.
- k) That the candidate must bear good conduct/character.
- l) That the Institute must submit the following duly certified documents along with a scholarship application form:
 - (i) Aadhar card, (ii) Mark sheets of 10th & 12th grades
 - (iii) Mark sheets of previous semesters for students in 2nd year onwards
 - (iv) Family Income proof/BPL Card, (v) Ration card
 - (vi) Any other document required by the Society
4. That to continue to receive the award from 2nd year onwards the Institute will be required to submit the following documents:
 - i. Certificate that the candidate has maintained 75% or above attendance during the preceding semesters of year.
 - ii. Mark sheet for the previous year semesters showing 70% of marks.
 - iii. An undertaking that the student is not receiving a scholarship from any other private or government organization.
 - iv. An undertaking that the student bears good conduct and behavior.
5. **Annual Assessment Test:** SBA will be administering an annual assessment test for the scholars to benchmark and measure their overall progress. Test performance will be considered as an input in scholarship renewals and/ or in granting new awards.

Note: Student who have already applied and received any kind of scholarship from any other source needs not to apply.
